

RED'S TICKET TO ADVENTURE SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

SWEEPSTAKES ENTRY PERIOD: The **Red's Ticket to Adventure Sweepstakes** (the "Sweepstakes") begins at 12:00:01 AM Eastern Time ("ET") on Thursday, July 21, 2022 and ends at 11:59:59 PM ET on Friday, August 19, 2022 (the "Sweepstakes Period").

ELIGIBILITY: The Sweepstakes is open to legal residents of the 50 United States, including the District of Columbia, who are age 18 or older at the time of entry. Void in Puerto Rico, Guam, the U.S. Virgin Islands, outside the U.S., and wherever else prohibited by law. Employees Red's All Natural, LLC (the "Sponsor"), US Sweepstakes & Fulfillment Company (the "Sweepstakes Administrator") and their respective subsidiaries, affiliates, advertising and promotion agencies, and the immediate family members (spouses, parents, children, and siblings and their spouses) of, and/or those living in the same household of each, are not eligible to enter. Sweepstakes is subject to all applicable federal, state and local laws and regulations.

By using the hashtags, participant indicates his/her agreement to these Official Rules. Entrant's Instagram settings must be public. Entries uploaded from "private" Instagram accounts will not be eligible. Entrants must follow and continue to follow @RedsBurrito through at least September 30, 2022 in order to be notified in the event he/she is a potential winner. Method #2 Tik Tok Entry. During the Sweepstakes Period, participant must log in to his/her public TikTok account, follow @RedsBurritos on TikTok, and upload and post a Photo or Video to his/her public TikTok account including the hashtags #AdventureWithReds and #Sweepstakes along with a story of who or what helped fuel his/her love for adventure, starting the story with "Red's this is my story" in the Photo or Video description (the "TikTok Post"). Participant must then visit

www.redsallnatural.com/AdventureSweepstakes and follow all entry instructions to complete the entry form, including the TikTok Post URL, and submit to receive one (1) entry into the Sweepstakes (the "Tik Tok Entry"). By submitting a Tik Tok Entry, entrants agree to TikTok's [Terms of Service](#). **This Sweepstakes is in no way sponsored, endorsed or administered by, or associated with, TikTok, Inc.**

Bonus Entry: Entrants will earn one (1) additional entry into the Sweepstakes by including Red's gear or product in their Photo or Video (the "Bonus Entry"). Purchase of Red's gear or product is not required and entrant can download an image to include in the Entry from <https://www.redsallnatural.com/>.

IMPORTANT: MESSAGE AND DATA RATES MAY APPLY TO USE OF MOBILE PHONE/DEVICE TO PARTICIPATE IN SWEEPSTAKES. INSTAGRAM AND TIKTOK ARE FREE TO DOWNLOAD AND AVAILABLE FOR IPHONE FROM THE APPLE APPLICATION STORE AND FOR ANDROID FROM THE GOOGLE PLAY STORE.

Sponsor may not receive entries from Instagram or TikTok users with "protected" accounts or profiles that are not public (i.e. user has set the Account so that only people the user has approved can view updates). Instagram posts not received by the Sponsor will not be entered into the Sweepstakes. Multiple participants are not permitted to share the same email address, Instagram or TikTok account. Incomplete entries will not be accepted and are void.

Instagram Entry and Tik Tok Entry collectively referred to herein as "Entry" or "Entries". Entrants are subject to all notices posted online including but not limited to the Sponsor's Privacy Policy, which can be found at <https://www.redsallnatural.com/privacy-policy/>.

Each Entry must include an original Photo or Video. Entries submitted with a Photo or Video that has already been submitted or that is substantially the same as a previously submitted Photo/Video, as determined by the Sponsor in its sole discretion, will be disqualified.

Limits of entry:

- **There is a limit of one (1) prize per person.**

All Entries must be received between Thursday, July 21, 2022 at 12:00:00 AM ET and Friday, August 19, 2022 at 11:59:59 PM ET. All methods of entry have an equal chance of winning.

For the avoidance of doubt, uploading a Photo or Video to Instagram or TikTok alone will NOT result in an entry into the Sweepstakes. Once an Entry is submitted it cannot be modified by an Entrant. Sponsor is not responsible for lost, late, incomplete, illegible, garbled, inaccurate, invalid,

misdirected, undelivered, or delayed Entries. No altered or incomplete submissions will be accepted.

SWEEPSTAKES ENTRY REQUIREMENTS & CONDITIONS: All Entries must comply with the following minimum guidelines to be eligible:

- No other individuals may appear in the Photo or Video without express written permission. If Photo or Video features a minor under the age of majority in his/her state of residence, you must obtain written permission from the minor's legal guardian.
- Entrant must be a registered user of Instagram to submit an Instagram Entry a registered user of TikTok to post a TikTok Post and must comply with each respective company's Terms of Use/Service in order to enter the Sweepstakes.
- Photos or Video submitted via Instagram or TikTok must include the hashtags #AdventureWithReds and #Sweepstakes in the photo caption or comment.
- Photos or Video must conform to the format and size requirements and limitations of the Sweepstakes Website, Instagram or TikTok.

PRIZES/APPROXIMATE RETAIL VALUE ("ARV")/ODDS:

Grand Prize: There is one (1) Grand Prize available to be won. The Grand Prize includes a trip package for two (2) people, winner and one (1) guest, to Missoula, MT. Grand Prize trip package includes:

- Round-trip, coach-class air-transportation for winner and one (1) guest to Missoula, MT from a major airport within the US nearest the winner's residence as determined by Sponsor;
- Five (5) days/Four (4) nights luxury moonlight glamping tent accommodations;
- Includes Breakfast, Lunch, Dinner, & drinks
- Many resort activities included (Yoga, Fitness Center, horseback riding, fly fishing, Fitness Trail, Volleyball, Badminton, Croquet, & bike rentals); and
- Round-trip car transfers to/from destination airport and hotel.

The ARV of Grand Prize: \$17,300. The ARV may vary based upon dates of travel and point of departure. The difference between the ARV and actual value of the Grand Prize will not be awarded.

First Prize: There are five (5) First Prize available to be won. First Prize includes one (1) \$500 Gift Card. **The ARV of the First Prize: \$500 each. Total value of all First Prizes is \$2,500.**

The total ARV of all prizes available to be won: \$19,800.

Odds of winning will depend upon the total number of eligible entries received.

RANDOM DRAWING: The winners will be selected in a random drawing on or about **Friday, August 26, 2022** from among all eligible entries received during the Sweepstakes Period by the Sweepstakes Administrator, an independent representative of the Sponsor whose decisions are final.

WINNER NOTIFICATION & VERIFICATION: In the event a potential prize winner entered via Instagram Entry, such potential prize winner will be notified by Sponsor via direct message and/or post comment to his/her public Instagram account (the "Initial Notification") on or about August 26, 2022. To begin the prize claim process, a potential winner must respond as instructed to the Initial Notification with his/her full name, address and email address within 48 hours of the Initial Notification. Any potential prize winner who does not reply to the Initial Notification with the required information and within the specified time period will be disqualified and an alternate winner will be notified. Within three (3) days of confirmation of the information received from a potential winner in response to Initial Notification, such potential Grand Prize winner will receive a second notification (the "Second Notification") via email from the Sweepstakes Administrator and will be required to sign and return, within seven (7) days of notification, an Affidavit of Eligibility, a Liability Waiver, an IRS W-9 Form and where allowable, a Publicity Release (collectively, "the Releases"). These Releases will require the Grand Prize winner to furnish his/her Social Security Number for the sole purpose of tax reporting, as required by law. Travel companion of winner will also be required to sign a Travel Companion Liability & Publicity Release. Noncompliance will result in disqualification and an alternate winner may be selected. Trip must be taken by **08/26/2023** or prize will be forfeited in its entirety. Such prizes will be awarded within 4-6 weeks after the winner is verified.

In the event a potential prize winner entered via Tik Tok Entry, such potential prize winner will be notified by the Sweepstakes Administrator on or about August 26, 2022 (the "Email Notification"). Potential Grand Prize winner will be required to sign and return, within seven (7) days of notification, the Releases as outlined above. Potential First Prize winners will be required to confirm their mailing address within 48 hours via return email. Noncompliance will result in disqualification and an alternate winner may be selected. Such prizes will be sent to the address provided at the time of entry or the new address provided within 4-6 weeks of winner being verified.

If a winner is otherwise eligible under these Official Rules but is nevertheless deemed a minor in his or her state of primary residence, the prize will be awarded in the name of winner's parent or legal guardian who will be required to execute and return the Releases on minor's behalf, as applicable and such parent or legal guardian must accompany Grand Prize winner as his/her travel companion on the Grand Prize trip.
